FIRST MODIFICATION TO DECLARATION OF COMMON INTEREST COMMUNITY FOR MEADOW LAND SUBDIVISION

This First Modification to Declaration of Common Interest Community for Meadow Land Subdivision, effective the 30th day of September, 2009, by Meadow Land Development Corporation, a West Virginia corporation (hereinafter referred to as "Declarant").

WHEREAS, Declarant caused to be recorded in the Office of the Clerk of the County Commission of Monongalia County, West Virginia, a Declaration of Common Interest Community for Meadow Land Subdivision, which Declaration has an effective date of March 1, 1987, and is recorded in said Clerk's Office in Deed Book No. 957, at Page No. 450 (the "Declaration"); and

WHEREAS, the Declarant desires to supplement the Declaration; and

WHEREAS, Meadow Land Property Owners Association, Inc., has joined in this Declaration, agreeing to the supplement of the Declaration.

- (1) That certain 12.97 acre, more or less, parcel as shown on the attached plat entitled "Plat of 12.79 acres to accompany Deed to Melissa K. & Edward M. Cyphert," is added to Meadow Land Subdivision as a single lot.
- (2) One single family dwelling may be placed on the 12.97 acre parcel. (3) The owners of the 12.79 acre parcel shall be bound to build the residential dwelling in accordance with the covenants applicable to Meadow Land Subdivision such as square footage and siding; however, all other covenants as to outbuildings, barns, livestock horses, and fences shall not be applicable; that the owner of said 12.79 acre parcel shall be obligated to pay the annual assessment as from time to time established for lots in Meadow Land.

This is a covenant running with the land and shall be binding on the 12.79 acres as long as the 12.79 acres is accessed through the Meadow Land Subdivision.
